

Establishment of Taipei Medical University - Research Center of Urology and Kidney

Adopted at the school affairs meeting on March 25, 109

Newly revised Order No. 1090001218 of Secret Word No. 1090001218 of TMU on April 13, 109, with 9 articles in full text

Article 1 (Purpose)

In order to implement the school's development goals, promote urinary and kidney characteristic research, and integrate urinary and kidney academic research manpower and resources, the "Taipei Medical University - Research Center of Urology and Kidney" was established in accordance with the "Taipei Medical University Research Center establishment and management measures", English name is "TMU Research Center of Urology and Kidney (TMU-RCUK)" (hereinafter referred to as the center), and the "Taipei Medical University Urology and Kidney Research Center establishment measures" (hereinafter referred to as the measures) have been formulated.

Article 2 (Center task)

The tasks of this center are as follows:

1. Innovatively integrate the fields of urology and kidney that originally belonged to different disciplines, re-group the functions, combine the expertise of the personnel, and exert additional effects and create characteristics.
2. Integrate basic and clinical resources to cultivate urinary and renal professional research talents.
3. Combine cross-field research, open up new research topics, increase research depth, and improve research quality.
4. Expand research capacity and implement large-scale cross-field research projects.
5. Implement translation research, promote the application of research results and technology transfer, develop innovative clinical service models, and improve the quality of medical care.
6. Research, teaching and medical treatment go hand in hand to create an internationally competitive urology and nephrology program.

Article 3 (Appointment of Center Director)

The center has a director to coordinate the administrative and research work

of the center, and the principal hires a person who has outstanding research in related fields and has made major contributions to the field.

Article 4 (Appointment of Deputy Director of the Center)

If necessary, the center may appoint three deputy directors to assist the director to promote the center's business, and may appoint several researchers and administrative personnel, who shall be appointed by the principal under the signature of the director.

Article 5 (Composition of the Advisory Committee)

The center may set up an advisory committee, composed of a number of scholars and experts at home and abroad who are signed by the director and the principal to assist in planning and promoting the tasks of the center.

Article 6 (Special matters that need to be handled in accordance with the school's regulations)

The center undertakes research plans, attribution and application of R&D results, industry-university cooperation, and industry feedback, etc., which shall be handled in accordance with the relevant laws and regulations of the school.

Article 7 (Income and Expenditure of the Center)

The center's revenue and expenditure are self-sufficient and should be regularly evaluated for research and operational performance.

Article 8 (Matters not covered)

Matters not covered in this method should be handled in accordance with relevant regulations of the school and relevant government laws and regulations.

Article 9 (Discretion)

This method shall be announced and implemented after being passed by the school affairs meeting; the same shall apply when amended.
